## Discussion

- 1. Introduction of committee members and staff.
- 2. Approve prior meeting minutes May 1, 2024 (available on <u>Google Drive</u>) Members
  - i. present from last meetings approved (11), others abstained (0).
- 3. Maureen delivered a presentation on Orientation CFAC's Role and Responsibilities
  - i. Presentation shared and saved on the Drive.
    - a. Question was asked whether the changes to the fee charged to non-student/outside students for taking the test need to be approved through the CFAC (For example, Nursing testing fee). Clarification was made that the fee changes for the non-students do not need to go through the CFAC for approval, but the fee charged to non-students for taking the test on campus would be treated the same way as for the students.
- 4. Mike presented the Annual Report of Campus Fees.
  - i. 2024 Annual Report of Campus Fees to CFAC Copy.pdf
    - a. Question was asked why the fund balance was not reported for some of the fees. Clarification was made that some fees are collected in one fund, but the revenue is split between multiple funds. For example, we collect Document Fee in one fund, but the revenue is split between Tower Card, Enrollment, and University Advancement.
  - ii. SSETF Review and Revamp: The Budget Office will share the proposed draft of updated guidelines in the next CFAC meeting for review.
    - a. Discussion regarding how some of the programs receive the annual funding continuingly by default but there might be some programs that are eligible as per the SSETF usage policy but did not get this opportunity of securing ongoing funding. For example, IT received an allocation of funds for laptops and desktops (technology) but later those were not needed anymore. However, those funds were never returned to the fund instead they were repurposed for other needs but at the same time, other departments had to compete to receive those funds which seems unfair. Discussion regarding improving the coding system in the ledger which will allow quick access to the data.
    - b. Question was asked if the SSETF fee rate is already approved for the years 25-26. Clarification was made that the fee rate for the 25-26 is
