- 2. Discussion regarding establishment of the Long-Term Exchange Programs Fee and how the fee is charged to students. Clarification as made that the this will be a new fee charged to students to cover administrative costs by Study Abroad and International Student & Scholar Services. The long-term study program is typically offered for one semester or the academic year versus the short-term study program is offered for two to four weeks, between the academic breaks.
