Alpha Tau Delta Nursing Fraternity

Case Creation Date:

- May 13, 2022

Incident Summary:

- *It was reported that on May 7, 2022 Alpha Tau Delta had an unregistered event with alcohol where under age alcohol use was observed.*

Student Organization Code of Conduct Violations:

- (2) Alcohol
 - A copy of the University's Alcohol Policy shall be provided to each student organization president and must be followed. The University's Alcohol Policy is in compliance with California Law, which prohibits the sale or giving of any alcoholic beverage to any person under the age of 21. Student organizations are in violation of University policy if any individuals under the age of 21 are in possession of alcoholic beverages at an activity sponsored/hosted by the student organization and/or if intoxicated individuals consume alcohol. All student organization presidents must sign an agreement to abide by and uphold the University's Alcohol Policy as well as present an alcohol awareness program to their organizations (should be pre-approved by the Prevention Education Program Center) or arrange for an alcohol awareness program approved by the Prevention Education Program Center. Student organizations sponsoring events are responsible for following the appropriate procedures to prevent underage drinking, including providing alternatives to alcohol.
- (08)(C) Failure to Comply with Student Organizations Handbook
 - (C) Failure to follow all policies and procedures established by the University pertaining to student organizations, including fraternities and sororities, as outlined in the Student Organizations Handbook.
- (12) Guests
 - Student organizations are responsible for informing their guest(s) of

University policies and procedures and will be held accountable for the behavior of their guest(s).

- (18) Risk Management of Events

Sanctions:

- **Formal Warning effective June 6, 2022.**
No disciplinary action will be taken by Student Conduct and Ethical Development on these charges. As a result of Conference, the student organization was informed of San José State University's policies and procedures; henceforth the student organization is placed on notice and is expected to maintain the community standards of the University.
- **Schedule a meeting with Student Engagement Coordinator - RSO, or other designee.** The president of the organization is required to attend a meeting with the Student Engagement Coordinator for RSO's, or the person's designee, to discuss how to properly register organization activities and to establish an organization plan for future events.

With respect to the information listed above, the following additional sanctions/stipulations apply:

Schedule a meeting with Student Engagement Coordinator - RSO, or other designee. The president of the organization is required to attend a meeting with the Student Engagement Coordinator for RSO's, or the person's designee, to discuss how to properly register organization activities and to establish an organization plan for future events
