Course Description

History, theory and functions of the juvenile justice system. The legal processes for delinquent minors, status offenders and dependent children, including intake, detention, adjudication and disposition. Current legal issues and debate.

Course Requirements and Assignments

“Success in this course is based on the expectation that students will spend, for each unit of credit, a minimum of 45 hours over the length of the course (normally three hours per unit per week) for instruction, preparation/studying, or course related activities, including but not limited to internships, labs, and clinical practica. Other course structures will have equivalent workload expectations as described in the syllabus.”

Your grade is derived from work in five (5) categories:

Homework Assignments (11) – Homework assignments are designed to review and enhance your learning of the week's topic by: reviewing key information, learning new details about a topic, practicing the application of a

rule, and/or making connections among concepts and readings. Homework assignments are completed at home and are worth approximately 12 points each. (CLOs 1 – 3)

On-call Q&A (3) – On three (3) days in the semester you will be called upon in class to answer questions about the material covered that day. If you do not attend lecture on the date shown, you cannot receive points for the Q&A, even in the event of illness or emergency. Each on-call Q&A day is worth 7 points. (CLOs 1 – 3)

Lecture Image (1) – On one (1) day in the semester you will present to the class an image that you believe captures the essence of one or more topics of discussion in the previous two lecture periods. In addition to your in-class statement to the class, you must also submit a one-paragraph written statement on CANVAS. Your date has been assigned in advance. I will accommodate reschedule requests received by **Feb 5**. If you do not attend lecture on the date shown, you cannot receive points for this assignment, even in the event of illness or emergency. Your lecture image day is worth 20 points. (CLOs 1 – 3)

Midterms (2) – There are two midterms in this course. Each is approximately 25 multiple choice questions and two essay questions.

- Midterm #1 covers Unit 1, theories of juvenile delinquency (CLOs 1 & 2)
- Midterm #2 covers Unit 2, the juvenile court (CLO 3)

Final Exam (1) – The final exam is a comprehensive written examination with multiple essay questions. You will receive the questions in advance. The final exam is worth approximately 100 points. (CLOs 1 – 3)

Extra Credit: Extra credit assignments may be offered during the semester. I will take into consideration students' proposals for extra credit assignments.
