ADMINISTRATIVE AND LEADERSHIP EXPERIENCE

Provost and Senior Vice President for Academic Affairs (July 2019-present), San José State University

Reporting to the President, I am responsible for the Division of Academic Affairs, which includes Enrollment Management, Undergraduate Education, Institutional Effectiveness and Strategic Analytics, Faculty Success, Academic Innovation, Academic Business and Strategic Operations, the College of Graduate Studies, the Office of Undergraduate Education as well as eight subject-matter colleges and the University Library. I also stand in for the president when she is not on campus or available.

Major Accomplishments

- Successfully manage ~\$375M annual divisional budget, with ~1500 Full-Time Equivalent Faculty, ~600 Staff, ~75 Management Personnel, and nearly 1,000 student workers while seeking out new resources to invest in divisional priorities, including increases in faculty hiring, advisor hiring, and new program development dollars supported through a reorganization of self-support reserves (allowing SJSU to invest in key initiatives without taxing stateside dollars);
- Hired inaugural deans for a new College of Graduate Studies and College of Health and Human Sciences, and College of Information, Data, and Society, while also successfully hiring deans of the Martin Luther King Library, the Lucas College and Graduate School of Business, and the College of Social Sciences;
- Reorganized [Division of Academic Affairs](#) central leadership (17 management direct reports), while not increasing the number of stateside-supported management personnel, to focus increased attention on (1) academic innovation, (2) faculty success, and (3) student success;
- Integrated Enrollment Management (Financial Aid, Admissions, Registrar, Technical Implementation and Communication, Student Outreach and Recruitment, and Testing Office) into the Division of Academics under a newly hired Senior Associate Vice President and relaunched our campus' Strategic Enrollment Management (SEM) Leadership group to advance our enrollment strategy and increase enrollment to the campus;
- Hired inaugural Vice Provost for Academic Innovation and Institutional Effectiveness, who launched [SJSU Online](#) and created new strategies for program assessment, professional and continuing education, and global education;
- Improved enrollment in stateside programs from a headcount of 33,282 (F'19) to 35,056 (F'25) and improved Professional and Continuing Education (PaCE) Enrollment from a headcount of 2,899 (F'19) to 5,066 (F'25) to include SJSU Online Undergraduate Students (875 enrolled F'25), managed the Enrollment Management team through a transition (March to July '24); as a result, improved PaCE Revenue from \$35M (2019-2020 AY) to an estimated \$71M (2025-2026 AY), while increasing overall campus PaCE reserves to a projected \$33.7M (2025-2026 AY);
- Hired inaugural Vice Provost for [Faculty Success](#) to reimagine training programs, which are now required of all faculty serving on Tenure and Promotion and Faculty Hiring Processes;
 - Successfully hired over 313 tenure/tenure-track faculty between 2019 and 2025 while bringing in most diverse tenure-track faculty classes in SJSU history while retaining several faculty who had competitive offers at other institutions;
 - The Center for Faculty Excellence and Teaching Innovation launched initiatives to enhance faculty well-being, on-boarding, mentorship, and Faculty Learning Community to enhance the ability of faculty and students to tell stories about their own experiences using multi-media technologies;
- Established new [strategic hiring themes](#) to focus on SJSU's core research and teaching strengths, building the campus' capacity to cluster hires across colleges with a shared vision and expertise;

- Enhanced the emphasis on the campus Research Scholarly and Creative Activities (RSCA) program by working with the Vice President for Research and Innovation to simplify the process by which SJSU award's RSCA assigned-time awards to our highly active faculty;
- Hired inaugural Assistant Vice Provost for Undergraduate Advising and Student Success, who has overseen the reorganization of academic advising on the campus to include a new cohort-based model of academic advising for students in their first sixty units with the goal of maintaining a 300:1 ratio for those students, increasing retention rates, and closing equity gaps (in process through 2022-2023), this is coupled with investments in training programs to better leverage technological innovations to support student advising;
- Managed transition to fully-remote online learning in the Spring of 2020 in response to the COVID pandemic, launched multi-million dollar training program, which has provided pedagogical strategies for nearly 2,000 faculty since the Summer of 2020 and successfully "repopulated" the campus in the Fall of 2021 and beyond (with Fall 2022 numbers just above 70% for face-to-face instruction on main campus);
- In collaboration with the non-profit Op-Ed Project, launched a four-year [Public Voices Fellowship Program](#) (in the first two years of that program, faculty produced nearly 200 opinion pieces, editorials, and/or news stories about their work at SJSU; SJSU faculty produced the highest number of Op Eds in November 2021, tying Yale faculty for the most of all Op Ed campuses);
- Created a sustainable model of investment in the essential work of the campus' compliance with NAGPRA and CalNAGRA in line with State law AB 275, establishing the first Tribal Liaison on campus to help SJSU comply with requirements for the repatriation of Native American ancestors temporarily housed in collections at SJSU;
- Launched an (un)Honors Task Force, to build an interdisciplinary academic program that can attract creative thinkers to SJSU to work on the region's and world's wicked problems (the Task Force proposed a new [HonorsX](#) initiative, which includes an academic minor as well as a reimagined admissions program based not on GPA and standardized test scores but ideas and an interest in collaboration, this launched in Summer of 2022);
- Developed successful proposal as one of the first three campuses to be part of [Adobe's Anchor School Program](#) (\$5M in gifts have helped SJSU launch an HSI Initiatives effort and invest in creative programs, such as HonorsX, Adobe Creative Cloud education, a new faculty learning community on digital storytelling pedagogies, SJSU's Career Center, an AI Hub, and SJSU's Beyond Sparta program);
- Supported Community and Government Relations (CGR) and Colleges of Science and Education in bringing earmarks to SJSU to support research and outreach programs (\$3M for [Moss Landing Marine Labs](#) and \$5M Wildfire Science, and \$500K for [Healthy Development Clinic](#));
- Collaborated to bring the nationally-recognized [Public Interest Technology University Network \(PIT-UN\) to SJSU](#) for its first west coast national convening (Fall '24).

Special Consultant to the Executive Vice Chancellor for Academic and Student Affairs (January 2024-August 2024), California State University

At the request of the CSU EVCASA, I took over strategic oversight of the Professional and Continuing Education (PaCE) Office of the CSU during transition. I was asked to be the system liaison to the CSU Commission on PaCE as well as direct to campus-based PaCE leadership. During my time, I developed several draft job descriptions, including the one for the new Assistant Vice Chancellor for PaCE, as well as several strategies for advancing PaCE education in the CSU. This includes the assessment of policies and educational codes that limit the CSU's ability to compete in the PaCE space nationally. I finalized a report to the system office in August 2024, which can be furnished upon request.

Interim Senior Vice Provost (September 2018-July 2019) **and Vice President** (March 2017-July 2019),
Academic Initiatives and Student Success, University of Arizona

Leadership and Administrative Oversight: I represented the provost on the Intercollegiate Athletic Association Committee, the Strategic Planning and Budgeting Committee, and the Undergraduate Council, among other shared governance groups. I was also lead on an \$82M capital project called the **Student Success District** project (<https://successdistrict.arizona.edu>). I oversaw the university's first leadership position for **Hispanic Serving Initiatives** and provided oversight of Academic Initiatives and Student Success Marketing, Business/Financial Affairs, and Research Assessment.

I also had oversight of four Provost Office areas: (1) academic and curricular affairs; (2) student success and retention innovation, (3) digital learning; and, (4) student engagement and career development.

(1) Academic Administration: In August 2018, the University of Arizona re-organized its central administrative areas to better align services and create a more cohesive administrative support structure. I was asked to oversee the registrar's office, curricular affairs, transfer articulation, transfer student support, and our central advising resource center. I held the title of interim senior vice provost a result of this transition.

(2) Student Success and Retention Innovation: In Fall 2016, I took over supervision of CATS Academics (athletic student support); Think Tank (tutoring and testing service program that delivers core tutoring services in math, writing, and other key areas of need); Strategic Alternative Learning Techniques (SALT) Center; and Academic Success and Achievement (ASA), now Thrive. Oversight also included first year success, four-year achievement, and probation services and serving diverse learning populations. These areas included over 90 FTE staff and more than 200 student workers.

Major Accomplishments

- Hired a new Associate Vice President for Student Success and Retention Innovation to oversee Think Tank, SALT, Thrive Center, CATS Academics, New Student Programs, and Academic Advising Resource Center (now includes a central strategy team as well);
- Established a new set of retention-related outreach efforts and strategic plan in collaboration with campus partners to increase first-time, full-time retention rates from 80.5% in Fall 2016 to above its board goal of at 83.3% in Fall 2017 and 81.2% in Fall 2018;
- Created outreach program that helps University of Arizona students return to the university to complete their degrees either through Arizona Online or one of our face-to-face campuses (four year graduation is nearly 50% and six-year graduation is approaching 65%);
- Provided leadership to develop new policies and programs to help students return to the University of Arizona, including our very successful Second Start Program;
- Participated on team that worked with Civitas Learning to advance predictive analytics capacity and build more robust student success campaigns that leverage mindset theory;
- Worked with the Colleges of Letters, Arts, and Science to integrate an interactive "gameful learning" platform into all their first-year success courses;
- Re-organized UA's first year Wildcat Academy student success program to include a new set of general education courses that incorporate supplemental instruction;
- Transitioned the Schedule-for-Success math support program from a smaller cohort (~600 students) to a more comprehensive experience for ~1800 entering first-year students in Fall 2018 (fall-to-spring persistence rates for this program has increased 5% Fall 17 to Fall 18);
- Collaborated with the Writing Program to create a supplemental writing workshop program for all new Arizona Online students to increase success in their first-year writing courses;
- Launched, through the leadership of the Thrive Center, a digital version of its successful student support program, Support-Opportunity-Success (SOS), for students and parents.

- (3) Digital Learning: Charged with leading Arizona Online, UA's fully online campus serving undergraduate and graduate students. Oversee programmatic and curricular development for online learning and participate in leadership role on digital learning more broadly. Directly manage budget related to expansion of online learning, including programmatic incentives, corporate initiatives, recruitment, faculty and student support. Oversee Office of Digital Learning (FTE = 26), Office of Online Recruitment and Marketing (FTE = 13), Online Student Success (FTE = 3, with 15 FTE in colleges supporting students), and Corporate Relations and Business Development (FTE = 2).

Major Accomplishments

- 2020 UNSWR Rankings (data reported summer 2019: 11th Online Bachelor's Degrees (8th for Veterans); Graduate Rankings 3rd in Information Science Technology, 10th in MBA, 48th in Education, 38th in Engineering, and 31st in Nursing;
- Growth of Arizona Online undergraduate enrollment from 244 in Spring 2016 (the first year of undergraduate admission to UA Online) to an estimated 2300 in Fall 2019;
- Growth of Arizona Online graduate enrollment to over 2,500 by Fall 2019 (with a 20% year-over-year enrollment growth in the first three years of Arizona Online (prior to Arizona Online, the Outreach College housed UA's fully-online graduate programs));
- The expansion of fully-online undergraduate and graduate degrees and certificates to over 100 options by Fall 2019;
- Growth of UA Online revenue to ~\$41M in Fiscal Year '18, with a projected revenue of ~\$56M in Fiscal Year '19;
- Development of an in-house enrollment, recruitment, and marketing team charged with all undergraduate and graduate lead generation for Arizona Online as well as Arizona Distance programs in Yuma and Phoenix, Arizona;
- Deployed ~\$6M marketing campaign, which includes new student recruitment efforts as well as efforts to recruit students back who left the UA and have not yet completed a degree (~20% of Arizona Online undergraduate enrollments are former Arizona students);
- Creation of policies to ease the transition of students to Arizona who left in poor standing but have been out of educational sphere for more than three years;
- Hired a Director of Corporate Initiatives and established corporate pipeline partnerships with ~20 companies to enroll their employees into Arizona Online programs.

- (4) Student Engagement and Career Development: Charged with implementation of University of Arizona's 100% Engagement Initiative, in which every student on campus is involved in extra-classroom experience. I coordinated work across the newly reorganized Student Engagement and Career Development area (24 FTE), Undergraduate Research and Graduate Pipeline Programs (1.5 FTE), and Innovate UA (1.0). I hired an Assistant Vice Provost for Student Engagement.

Major Accomplishments

- Established infrastructure that allows for nearly 500 credit-bearing and 60 non-credit engaged learning experiences to formally count in the 100% Engagement Initiative;
- Over 75% of the Spring 2018 undergraduate students graduated with an "engaged learning" notation on their transcript (this is just the second year that formal experiences are available to inform the transcript notation; in the Spring of 2016 just over 30% of graduating undergraduates had received a formal transcript notation);
- Completed a \$600K Governor's Office Workforce Development grant around university-corporate partnerships increasing opportunities for UA students in Phoenix, Arizona;
- Through the leadership of the new Assistant Vice Provost for Student Engagement the institution finalized the reorganization of three departments – Career Services, Leadership Programs, and the Office of Student Engagement – into one unit called Student Engagement and Career Development;

- Supported programming that offers a new set of “fast track” skills-based learning programs in areas such as digital marketing and Adobe Creative Suites applications and semester-long, non-credit design-thinking challenges that now enrolls over 100 students a year in solving key challenges for campus partners in the Student Union and Facilities Management;
- Helped establish UA as the first Adobe Creative Campus in the Western United States, providing undergraduate students with full access to the entire suite of Creative Cloud products; hired a dedicated staff person to work through the Office of Digital Learning to collaborate with faculty and other staff on integration of creative literacy learning into everyday student campus practice.

Vice Provost, Digital Learning and Student Engagement/**Associate Vice President**, Student Affairs and Enrollment Management, July 2014- March 2017

I was charged with the launch of Arizona Online (<https://online.arizona.edu/>). In this capacity, I developed the leadership team for UA Online including: (1) Director, Digital Learning and Online Education who built the Office of Digital Learning (including hiring an associate director, three instructional designers, two video/production managers, an instructional technologist, and a graphic/web designer; current FTE 12.5 (<http://odl.arizona.edu>)), (2) Director of Online Student Success (with collaborative oversight of 7.0 FTE student academic success specialists in partner academic colleges (and another 2.0 central support staff), (3) Director, Online Student Recruitment for UA Online programs who built an entire in-house recruitment team (now an office of 8.0 FTE), (4) Director, Corporate Initiatives Business Development (established 3 corporate partnerships in first six months of 2016), and (5) Marketing Manager who oversees all UA Online marketing strategies (growing to 3.0 FTE in Fall 2016); created the UA General Education Academy and a UA Online Science Academy; developed an infrastructure for student support services; coordinated with senior leadership in the Senior Vice Provost’s office to reorganize the division to meet the diverse needs of students in academic programs that are not located on the main campus; continually leading campus discussion on how model of online education will develop; providing ongoing support to the marketing and communication efforts related to online learning; helping manage programmatic startup funds equal to several million dollars for new program development.

I also led the reorganization of the area of engaged learning to bring together Career Services, Leadership Programs, and Office of Student Engagement under an Assistant Vice Provost, Student Engagement (July 2016); established the administrative support Office of Student Engagement (OSE; <http://ose.arizona.edu>) to help expand engaged learning efforts across campus (includes a new space in the student union, August 2015); hired an Associate Director and Senior Program Coordinator to manage OSE; created university policy from a Task Force report, which I co-authored, that allows students to graduate with “Engaged Learning Experience” notation on their transcript; established mechanism by which academic colleges could hire “engaged learning professionals;” developed system mechanism to insure student engagement efforts appear on the transcript and on a “Student Engagement Record;” ongoing assessment of how to expand competency-based education efforts, including the development of digital badging portfolio for all UA students; Co-Principal Investigator on a \$600,000 Workforce Development Grant to establish student pipelines to profit and non-profit businesses, particularly in the greater Phoenix Metro area.

Chair, Honors College Re-Envisioning Task Force, University of Arizona, Academic Year 2015-2016

In fall 2015, the founding dean of the Honors College announced her intent to retire from her post. The provost called together a task force to “re-envision” the Honors College. The Task Force collected data on how students, faculty, staff, parents, and alumni view honors education now and into the future. The report provides recommendations for how the college might evolve over the next 5-10 years. This “brainstorming” report guides the development of a job advertisement for the next dean of the college.

Associate Dean, College of Social and Behavioral Sciences and Colleges of Letters, Arts, and Sciences, University of Arizona, July 2011- July 2014

Served as associate dean in the College of Social and Behavioral Sciences and its 280+ faculty, ~6000 graduate and undergraduate students, and 21 units. Oversee curricular and programmatic development, directly manage teaching budget in support of graduate student teaching assistantships, adjunct faculty, and multi-year lecturers (~\$4m) and provide input into larger college budget (direct costs ~\$30m), and coordinate course offerings with other colleges, including the UA Honors College. Lead initiatives related to enrollment management and budgeting strategies within the college. Serve as the dean charged with oversight of student academic integrity, grade appeals, and disqualification appeals. Those reporting directly to me include the director of academic advising and student services, the research support and enrollment manager for the dean's office, and the Office of Instructional Assessment SBS liaison. Other duties include: service on university-wide committees and task forces related to responsibility-centered management (RCM), programmatic assessment, curriculum and programmatic development, and non-tenure track faculty policy. In addition, I serve as an associate dean for the Colleges of Letters, Arts, and Sciences (CLAS), an interdisciplinary collection that brings together the colleges of Social and Behavioral Sciences, Science, Humanities, and Fine Arts under one larger umbrella organization. In my job as part of CLAS, I work on interdisciplinary degree programs and outreach efforts that span the four participating colleges. This includes helping to oversee interdisciplinary degree programs in Global Studies (BA and BS), Interdisciplinary Studies (BA), and a Bachelor's in General Studies (BGS).

Chair, Department of Geography, CSU, Long Beach, August 2007- July 2011

Served as chair of department of 12 full-time tenure-track faculty members and 6-12 lecturing faculty. Oversaw B.A. degree in Geography, M.A. in Geography, and Certificates in Urban Studies and Geographic Information Sciences. Charged with program review, yearly assessment of all degree programs, expanding departmental development efforts, developing effective course scheduling and budget planning, and mentoring faculty. Accomplishments included: (1) initiated a Professional Science Master's (PSM) in Geographic Information Sciences (GIS) as well as a Minor in GIS; (2) coordinated a \$50,000 grant to support the development of the new master's program in collaboration with the College of Continuing and Professional Education; (3) expanded development efforts, including establishing the Frank Gossette Award in support of graduate student research; (4) inaugurated the department's Facebook page and managed the website and outreach materials for the department; (5) coordinated a research team of faculty from three departments (Communication Studies, Psychology, and Geography) to develop grants related to health geography and HIV-related research (first grant submitted September 2010); (6) established internship program with local consulting firm; and (7) developed an alumni advisory board to the department.

Vice-Chair, Academic Senate, CSU, Long Beach, Academic Year 2009-2010

Assisted the Chair of the Academic Senate in the administration of the university's leading shared-governance body. Oversaw the Senate Retreat on Budget Planning, participate in the Executive Committee of the University's WASC Accreditation Committee, and developed procedures to more effectively administer the university through a model of shared administration-faculty-staff-student governance. Specific goals accomplished, include (1) coordinated the Senate Retreat on Budget Planning; (2) participated in all interviews of administrators for positions above the rank of associate dean; and (3) facilitated a discussion of the organizational structure of the Academic Senate and its various committees and councils.
